Attached are financial statements reflecting the first quarter of 2016.

While winning a \$2,000 Whole Kids Foundation grant recently is great news for the Vegetable Project, the receipt of such funds raises the need for care in interpreting financial statements. The Vegetable Project had \$3,518.56 available in cash for general operating purposes on March 31, 2015, and \$1,319.85 for development of an outdoor classroom. Net income for the first quarter was \$2,593.75. It would be prudent, however, to remember that \$2,000 is meant for the greenhouse, effectively reducing the general operating fund and first-quarter net income by that amount.

The still positive results were buoyed by \$791.80 in donations, including \$450 from the Myers PTSA. And although handling Boxtops for Education takes quite a bit of time, it is worth noting that the \$279.50 in proceeds from a November submission was the second largest source of revenue. Indeed, it is growing year after year as other revenue sources weaken. Expenditures in the quarter were mostly for tools and supplies for individual classrooms, including grow lights for two additional rooms at Myers.

As suggested with the year-end 2015 report, sustaining and then increasing revenue in the year ahead, whether through donations, seed sales, bulb sales, Boxtops collections and grant opportunities, likely depends on boosting visibility as much as anything else, and especially boosting visibility beyond our school communities.

2010 -- \$2,000 grant is from Lowe's

2012 -- received about \$1,500 worth of supplies and materials from WellPoint and about \$500 in cash after returning items purchased by WellPoint. Not reflected, however, in financial statements.

2014 -- Flower Power bulb fundraiser was conducted in 2013 and 2014. All income, however, was received in 2014, due to delay in receiving check from 2013 campaign.

BoxTops have been submitted at different times of year, making comparisons difficult.

2015 -- incorporation and tax-exempt status cost \$485
